- PURPOSE:

This AIC aims to clarify aviation security procedures at airports to maintain the highest standards of security in facilities and aviation operations. The goal is to prevent potential threats by:

- 1. Controlling access to sensitive areas.
- 2. Restricting the use of electronic devices.
- 3. Regulating the transport of prohibited materials (especially liquids and gels).
- 4. Managing the escorting of travelers.

- DETAILS:

1. Access Control at Airports

- a) Prohibit unauthorized personnel from accessing airside areas (runways, inner departure lounges, cargo zones, etc.).
- b) Limit access in front of arrival halls to authorized personnel only.

2. Restrictions on Electronic Devices

- a) Use of Mobile phones and wireless communication devices are not allowed in central and subsidiary inspection points (e.g., at gates and security screening centers).
- b) Mandatory use of explosive trace detection device at a random rate of 10%.

3. Regulations on Liquids and Gels

- a) Containers of liquids and gels (such as creams, toothpaste, beverages) exceeding 100 milliliters are not permitted in hand luggage.
- b) Only containers up to 100 milliliters are allowed, provided they are placed in a transparent bag.

4. Escorting of Travelers

Escorts are not permitted in passenger halls, except in the following cases:

- a) Elderly individuals (seniors).
- b) Persons requiring medical assistance.
- c) Individuals with disabilities and special needs.
- d) Women and minor children (under 12 years).
