Approval of Flight Simulators Training Devices (FSTD) Policy

1. PURPOSE

This advisory circular (AC) provides guidance for organizations to receive Libyan Civil Aviation Authority (LYCAA) approval to use Flight Simulator Devices to provide instruction under Part ORA of the Libyan civil aviation regulations Part Air Crew.

2. BACKGROUND

- 2.1. Any flight simulation training device to be used by a Libyan aircraft operator for qualification for flight crews is subject to LYCAA approval, prior to use in an approved training curriculum.

3. APPLICABILITY

This AC is applicable to all individuals, operators, organizations and other aviation entities desiring to provide training and qualification required by the Libyan aviation regulations.

4. RELATED REGULATIONS

The following regulations are directly applicable to the guidance contained in this advisory circular—

- LYCARs Part FCL, Personnel Licensing
- LYCARs Part ORA Subpart ATO, Approved Training Organizations
- LYCARs Part ORO, AOC Personnel Qualification

5. LYCAA FLIGHT SIMULATORS APPROVAL POLICY.

- 5.1. LYCAA Approval process is divided into two categories (depends on base FSTD approval)

- 5.2. Category 1: FSTDs approved by the following Organisation

- European Aviation Safety Agency (EASA)
- Federal Aviation Agency (FAA)
- Transport Canada (TC)

- 5.2.1. LYCAA shall Issue an FSTD Approval based on valid approval issued by the above organisations.

- 5.2.2. The requirements for granting approval for this Category is

- Completed Application Form
- Copy of Valid FSTD approval issued by organisations listed in 5.2.
- Request letter from the FSTD Operator
- May require an LYCAA onsite audit if the device located outside the above listed territories.

- 5.3. Category 2 – FSTDs approved by other national authorities:

- 5.3.1. Applicant for FSTD approved by other national authorities shall contract the organisations mentioned in 5.2., and obtain the required STD approval.

- 5.3.2. In certain cases LYCAA may issue an approval to this Category provided

- (a) The national authority has excellent level of aviation safety (ICAO USOAP Report)
- (b) Assessment shall be carried out to include:
 - FSTD Quality system
 - FSTD Maintenance record and process.
- (c) Review of the last FSTD certification carried out by the national authority.

6. LYCAA plan.

- 6.1. LYCAA shall qualify its own personnel to conduct FSTD certification.

- 6.2. As soon as this accomplished. FSTD Approval shall be based on LYCAA certification process.
